

Terms and conditions of BLS AG for points cards for Lötschberg car transport

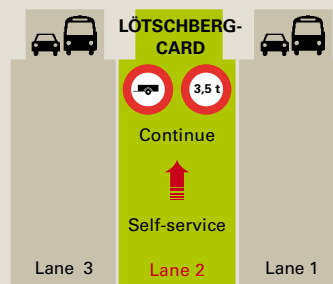
1. General conditions

- Points cards are valid for Lötschberg car transport and Furka car transport.
- **Points cards are valid without time limit for the following categories:**
 - Motorised vehicles up to 3.5 t total weight / motorhomes up to 5 t total weight: Category 1
 - Trailers/caravans 0.75–3.5 t total weight: Category 2
 - Trailers/caravans up to 0.75 t total weight: Category 3
 - Motorcycles over 50 cm³ with/without sidecar and tricycles: Category 4
 - Bicycles, motorcycles, small motorbikes up to 50 cm³: Category 5
- Points cards are transferable and can be topped up.
- Each time you drive onto the train you will receive a ticket showing your current points balance.
- Points cards cannot be stored at car ticket vending booths.
- There can be no refund of tickets that had to be used because a points card had been forgotten.
- In the case of loss, registered points cards can be replaced in return for a fee as per Clause 6. Registration can take place online at www.bls.ch/point-cards or by completing the form issued at the time of purchase. We are unable to replace non-registered points cards.
- Use of the self-service lane is possible for motor vehicles of up to 3.5 t in total weight without a trailer.

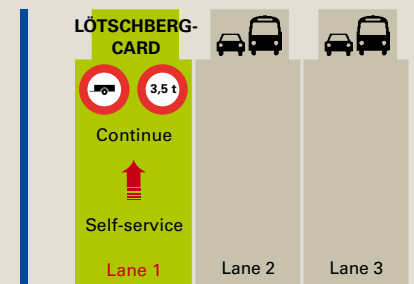
Self-service lane

For points cards holders with a motor vehicle of up to 3.5 t in overall weight without a trailer

- Observe the lane signage (see right).
- Drive up to the machine in the ticket cabin.
- Hold your points card against the red point for approx. 3 seconds.
- A receipt with your current points balance will be issued.
- Please remove the receipt. The barrier will open automatically, and you will be able to proceed.
- Please retain the receipt during the trip; it doubles as your insurance certificate.

Note

To ensure that all car transport customers are processed more quickly, the self-service lane will be changed to staffed ticket validation and sale on days with high levels of traffic. The lane signage will be updated accordingly.

5. Conditions for the refund of a points card

- Partially used points cards may be refunded in return for a fee as per Clause 6.
- You'll only start to benefit from the discount of the purchased points card once all the points have been used. Bonus points cannot be refunded.

7. Liability

8. Place of jurisdiction and applicable law

The place of jurisdiction is Bern. Swiss law shall apply to the contractual relationship.

9. Changes to the terms of use

BLS AG is entitled to change the present terms of use at any time. The current version is published online.

10. Partial nullity of the terms of use

Should one or several of these clauses be void by law, the binding force of the remaining clauses will remain unaffected by this. In such a case BLS AG will replace the void by law or invalid clauses with lawful clauses of equivalent commercial value.
